Synopsis

During 14 years as Master on 22 vessels and 9 years as Chief Officer on 12 vessels, I gained experience on tankers, bulk carriers (handy to cape size), OBO and general cargo/container vessels.

During four years of shore based work experience with ship management companies, I gained experience in managing oil tankers, chemical tankers, gas tankers, bulk carriers, container, Ro-Ro and Ro-Pax vessels.

As a marine consultant since 2010, I have worked on various matters involving various navigational incidents, fire, capsizing, crew injury/death, unsafe port disputes, bulk and liquid cargo quality and quantity disputes, over-pressurisation damage to cargo tanks, loss of containers, cargo liquefaction disputes, new building disputes, cargo/crane damages, and wreck removals besides others. I have carried out numerous navigational audits, pre-purchase inspections, condition surveys, and towage approval surveys.
